# Categories of data processed and source of data

For the treatments, the Data Controller will process common data, such as personal data, contact data, address data, payment data, data relating to purchases or use of services, access, and identification data, data relating to identification/recognition documents, data on the composition of the household, assessment data, attendance/absence data. #### **Provision of Data**

For the aforementioned purposes, the provision of your data is a requirement, in case of failure to provide it may not be possible to carry out the treatment.

#### **Data Recipients**

Your data may be communicated exclusively for technical and operational needs strictly connected to the aforementioned purposes, to subjects who process the data on behalf of the owner, appointed as authorised or responsible for the treatment under art. 28-29 of the EU Reg. of 2016/679 as well as to public structures concerning which there is a legal obligation to communicate (by way of example and not exhaustively, the ULSS of reference).

## Non-EU data transfer

The processing of personal data (e.g. storage, archiving, and conservation of data on its servers or in the cloud) will be limited to the areas of circulation and processing of personal data in countries belonging to the European Union, with the express prohibition of transferring them to countries outside the EU that do not guarantee (or in the absence of) an adequate level of protection, or, in the absence of protection instruments provided for by EU Regulation 2016/679 (the third country deemed adequate by the European Commission, group BCR, model contractual clauses, consent of interested parties, etc.). For Google Workspace for Education services, a specific disclosure has been prepared.

## Rights of the interested party

- The parent/guardian has the right, according to the provisions of article 15 and following of EU Reg. 2016/679, to request the Data Controller to access his/her personal data, as well as their correction and cancellation or oblivion.
- The parent/guardian has the right to request data portability or limitation of processing;
- The parent/guardian has the right, for reasons related to his/her particular situation, to object to the processing based on the legitimate interest of his/her personal data;
- For treatments based on consent, the parent/guardian has the right to revoke the consent at any time, without prejudice to the lawfulness of the treatment based on the consent given before the revocation;
- The parent /guardian has the right to view the essential contents of the joint controller agreements;

#### WHAT PERSONAL INFORMATION DOES GOOGLE COLLECT?

When creating a student account, EISP S.r.l may provide Google with certain personal information about the student, including, for example, name, email address, and password. Google may collect personal information from students, such as telephone numbers for account recovery or a profile photo added to the Google Workspace for Education account.

#### When a student uses Google services, Google also collects information based on the use of those services. This includes:

- device information, such as the hardware model, operating system version, unique device identifiers, and mobile network information including phone number;
- log information, including details of how a user used Google services, device event information, and the user's Internet protocol (IP) address;
- location information, as determined by various technologies including IP address, GPS, and other sensors;
- unique application numbers, such as application version number;
- cookies or similar technologies which are used to collect and store information about a browser or device, such as preferred language and other settings.

#### HOW DOES GOOGLE USE THIS INFORMATION?

In Google Workspace for Education Core Services, Google uses students' personal information to provide, maintain, and protect the services. Google does not serve adverts in the Core Services or use personal information collected in the Core Services for advertising purposes.

#### WHICH CHOICES ARE PARENT/GUARDIAN ENTITLED TO?

If the parent/guardian authorises the enrolled student to use Google Workspace for Education, the parent/guardian can access or request deletion of the Google Workspace for Education account by contacting EISP S.r.l. To stop any further collection or use of the enrolled student's data, the parent/guardian may request that we use the service controls available to limit the enrolled student's access to certain features or services or terminate the enrolled student's account entirely. The parent/guardian and the enrolled student can also visit <a href="https://myaccount.google.com">https://myaccount.google.com</a> while signing in to the Google Workspace for Education account to view and manage the personal information and account settings.
